PROGRAMME INFORMATION, PROGRAMME TERMS AND ACADEMIC INSTITUTION'S COMMITMENT November 2021 (for January 2022 deadline)

General Information and Programme Policy

- 1. The Clore Scholars Programme was established in 1991 by the Clore Israel Foundation, with the aim of promoting outstanding young Israeli scientists, and in the hope that the programme will contribute significantly to furthering scientific excellence in Israel. The programme is directed by an independent Board of seven members, comprised of senior academic scientists, the Chairman of the Clore Israel Foundation, one of the Foundation Trustees, and leading public figures from the worlds of high tech and business.
- 2. Institutions participating in the programme are as follows: Bar-Ilan University, Ben-Gurion University of the Negev, Hebrew University of Jerusalem, Technion Israel Institution of Technology, Tel Aviv University, University of Haifa and Weizmann Institution of Science.
- 3. Scholars are selected each year from among students and researchers pursuing a career in all fields of the natural sciences, including mathematics, physics, chemistry, the life sciences, earth sciences, computer science, agriculture, engineering and technology.
- 4. The Scholarship for the next academic year is intended for Doctoral students in the Sciences who fulfil the following criteria:
 - i. Students who have begun their doctoral studies not more than one and a half years before the deadline date for the submission of the application, i.e. no earlier than 16.7.2020. Please note: It is recognized that there may be exceptional circumstances, such as pregnancy, birth of a child or illness, where an application may need to be postponed. Such exceptions will be considered individually. Requests for postponement should be submitted by the academic institution to the Programme Coordinator via email.
 - ii. Students who have submitted their doctoral proposal, even if this is not yet approved. In this case, the submitting institution is obliged to notify the programme coordinator immediately upon receipt of approval of the doctoral proposal. The awarding of the scholarship is dependent on this approval.
 - iii. It is possible to submit candidates on a Direct to PhD programme who have commenced their Doctorate at a date that is in accordance with the University regulations for that programme, but only on condition that their doctoral proposal has been submitted (see note ii above) and they are no more than one and a half years into their PhD studies.
- 5. The Scholarship is intended for excelling students in the Sciences, and will only be awarded on the basis of excellence in their studies and research.
- 6. The Scholarship is intended only for students who have Israeli citizenship and who are studying in Israel at the participating academic institutions (see note 2).
- 7. The Scholarship is intended only for students who are conducting their research in the framework of the submitting academic institution and who are not employed by any other body.
- 8. Up to ten new scholars per year are appointed for a maximum three-year scholarship, which is currently set at \$27,000 per year and is paid via the academic institution. The scholarship term is for three academic years or until the thesis has been submitted. In addition, recipients receive a one-time grant of \$8,000, which is comprised of a personal prize of \$3,500 and an allowance for research-related expenses of \$4,500. The personal prize is presented to the recipient as a cheque in New Israeli Shekels at the Award Ceremony and is to be used by the scholar for personal purchases not related to research. The Research Expenses grant is transferred to the academic institutions, together with the first scholarship payment, and is to be used by the scholar for research related expenses such as computers, conferences etc.

- 9. In certain cases, the selection committee may wish to personally interview candidates.
- 10. A separate agreement has been signed between each academic institution and the Clore Scholars Programme and details the relevant financial arrangements.
- 11. Each year a quota of applications is fixed for each academic institution in relation to the number of doctoral students in the sciences in that institution, including students on an MD/PhD programme. In the case of MD/PhD students, an extra two applications is allowed in addition to the institution's set quota. Should an institution be submitting more than two MD/PhD students, only two of them will be allowed above the set quota.
- 12. The fixed quota for each academic institution relates only to the number of submitted candidates and not to the number of award recipients. The only consideration that the selection committee will make is on the basis of excellence in studies and research. The selection committees do not take into account the candidate's academic institution when making their decision.
- 13. Applications will be submitted by the academic institutions to the Clore Scholars Programme according to the relevant regulations and terms.
- 14. The academic institution must commit to exempting the scholarship recipient from tutorial fees, as is the practice with all such scholarships.
- 15. Each November, the Clore Scholars Programme will issue a Call for Applications, sending the relevant application documents to all the academic institutions by email. It is incumbent on the institutions to submit their applications by email in PDF format as per the regulations detailed in the Applications Submission Regulations document (document number 3).
- 16. The Clore Scholars Programme application submission deadline is **Sunday 16 January, 2022**. Students are required to submit their application form to their academic institution by the application deadline date set by that institution.
- 17. The announcement regarding the scholarship recipients will be published by **the end of June 2022.**
- 18. The decision of the Clore Scholars Programme Board is final and binding and not open to appeal.
- 19. Applications to the Clore Scholars Programme may not be concurrently submitted to the scholarship programmes of the Adams Foundation, Azrieli Foundation or the Edmond de Rothschild Foundation.

Academic Institution's commitment

The Academic Institution commits to the following:

- 1. To submit no more than the appropriate number of applications, as set by the Programme.
- 2. To ensure that candidates have begun their doctoral studies not more than one and a half years before the deadline date for the submission of the application, i.e. no earlier than 16.7.2020. Please note: It is recognized that there may be exceptional circumstances, such as pregnancy, birth of a child or illness, where an application may need to be postponed. Such exceptions will be considered individually. Requests for postponement should be submitted to the Programme Coordinator by email by the academic institution.
- 3. To ensure that candidates have submitted their doctoral proposal, even if this is not yet approved. The awarding of the scholarship is dependent on this approval.
- 4. To notify the programme coordinator immediately that approval of the doctoral proposal has been received.
- 5. To submit yearly reports to the Scholarship Programme, notifying that each recipient is continuing their studies to a satisfactory standard.
- 6. To report on any disruption to the recipient's studies and research for a period of longer than six months. A period of disruption longer than one year will not be permitted.
- 7. To ensure that the scholarship recipient completes their research during the three year period of the scholarship. If it becomes clear that there is little chance of the recipient completing the research within the given period, the Clore Scholars Programme reserves the right to halt the scholarship payments before the full term of the scholarship has been reached.
- 8. To allow the scholarship recipient to receive additional grants from other sources according to the following conditions:
 - i. Additional income from internal sources in the academic institution, on the condition that the income is not more than 50% of the Clore Scholarship payment.
 - ii. This income, together with the Clore Scholarship, will not be more than the maximum allowed by the academic institution.
 - iii. During the period in which the Clore Scholarship is being received, the recipient may not be employed in teaching by the academic Institution for a period greater than a quarter of the total acceptable teaching shift period.
- 9. To ensure that the scholarship recipient will not be employed outside the academic institution and that the research is carried out within the framework of the academic institution.
- 10. The academic institution must commit to exempting the scholarship recipient from tutorial fees, as is the practice with all such scholarships.
- 11. The academic institution must commit to not debiting any sum from the scholarship funds without prior permission from the Clore Scholars Programme.

APPLICATIONS SUBMISSION REGULATIONS AND GUIDELINES November 2021 (for January 2022 Deadline)

Applications are to be submitted as two separate PDF files, as follows:

1st PDF FILE to include the following in the below order:

- 1. Application form + Candidate's Declaration and Commitment (טופס בקשה והצהרת המועמד) with passport photo attached in relevant space, and signed with original signatures only.
- 2. **CV (קורות חיים)** maximum 2 pages, in English, in the following order:
 - o Higher Education and Training (השכלה גבוהה והכשרה)
 - Military service (if applicable) (שירות צבאי)
 - Work experience (if applicable) (ניסיון עבודה)
 - Awards and Honours (פרסים והוקרות)
 - Poster and Oral Presentations at Conferences (הרצאות) Lectures should only be listed if they were given in the framework of a conference
 - Volunteering and Educational Work (התנדבות והוראה)
 - Publications (פרסומים) as follows -
 - List of publications appearing in Scientific journals please note the current stage of the article, accepted or published
 - The list is to be formatted as per the 'Cell' format for Life Sciences students, or according to the commonly applied standards in the relevant fields for applicants in the Mathematical, Physical or Chemical Sciences. The name of the applicant is to be marked in bold. Do not include in the list any articles that are only in the preparation stage
 - Do not include in the list any articles that have been submitted but not approved, unless they appear on an archive that can be accessed, or are hosted on BioRxiv
 - Note the number of citations, if relevant, but do not quote the actual citations
 - Do not include impact factors
 - The list of publications must be in two parts the first part concerning only Original Research Papers and the second part only Reviews
- 3. Recommendation letters (מכתבי המלצה) Please attach at least 3 signed recommendation letters, including a letter from each of the candidate's supervisors. The supervisor's original signature is essential and their letters should appear before the other letters. All recommendation letters must be printed on the relevant institution's letterhead and addressed to the Clore Scholars Programme.
- 4. The research proposal summary and the research proposal (הצעת המחקר ותקציר ההצעה) these should include the following and in this order:
 - The summary should be approximately 400 words in length and aimed towards scientists that are not necessarily from the same scientific field. It should appear before the research proposal.
 - The proposal should be of 2 3 pages in length and aimed towards scientists that are not necessarily from the same scientific field. The proposal should include a description of the general problem, open questions, general and specific research goals, work plan principles, expected results and the relevance and importance of the research.

- 2. **Details of studies (אישורי לימודים)** to be included, as follows:
 - Registration approval for the relevant Academic year
 - Institution approval of candidate's acceptance to Doctoral studies, with research subject noted in English
- 3. Academic Institution's commitment (התחייבות המוסד האקדמי) only signed version of Page 3 is required.
